Notes to the aforementioned:

^d Considerable increase in budget to fund cemetery garage and wheelchair accessible play equipment projects (earmarked reserves codes to be allocated). Alternatively, any expenditure for these projects could be taken directly from general reserves? An additional £1,000 added to Code 226R (Play area improvements/upgrades) to fund any railing and gate maintenance work required in future years. Increased budget for Code 212a (Cemetery Repairs/Renewals) to fund memorial testing programme and alterations to cemetery gate hinges. 100% of cemetery income now being allocated under Code 260R (Future burial provision) rather than 50%.

The aforesaid breakdown of figures is included in the attached Budget Report.

- 9. To discuss the Finance Committee budget for the year 2022/23 and for the forthcoming fiscal year 2023/24 (see attached budget spreadsheet and Supporting Paper 2).
- 10. To set the precept request for the approval of the Parish Council. The number of Band D equivalents after taking account of discounts and exemptions for 2023/24 is 2,125.8 (previous year was 2,080.6).

Example 1: Maintaining the same Band D precept charge as 2022/23

The Band D precept charge for Helsby Parish Council in 2022/23 was £49.32. If you want this charge to be the same in 2023/24, you will need to request a precept of £104,844.

^a Increased budget to pay for lone worker's alarm and H&S training courses.

^b Reduced budget as Clerk now completed CiLCA training.

^c Small reduction in budget – no funds allocated to village clock (Code 219), reductions in Sherwood Court and Maltby Triangle codes (220 and 229) as grass cutting in these areas now covered under Code 214 and tree maintenance work carried out this year and reduction in street furniture/BT boxes (Code 230) as BT kiosk work completed in 2022/23.

Example 2: Requesting the same precept as in 2022/23

In 2022/23, Helsby Parish Council requested a precept of £102,615. If you were to request the same precept for 2023/24, this would reduce the Band D precept charge by £1.05 to £48.27.
